


or polling stations with limited capacity and wearing a mask.

- Rockford Housing Authority encourages all Rockford residents to register to vote and let their voices be heard in the upcoming election on November 3rd, 2020. Remember, your vote matters.




REFLECTION OF LABOR DAY



CDC HALTS EVICTIONS THROUGH THE END OF THE YEAR

The White House issued a statement to announce the Centers for Disease Control and Prevention (CDC) will halt evictions through the end of the year per the agency's directive in the executive order issued on Aug. 8. Deeming that widespread evictions pose significant risk to the spread of COVID-19, the CDC published the new agency order in the Federal Register.



- 1. Renters must not exceed the thresholds for receiving an Economic Impact
- 2. Payment under the CARES Act.
- 3. Renters will also be required to demonstrate to their landlord or property manager that they have:

Experienced a loss of income, Made best efforts to pay rent, Attempted to obtain relevant government assistance, and, If evicted, would likely become homeless or forced to live in congregate housing

Please be aware that Tenants may still be evicted for the following:

Housing Authority and provide opportunities to Rockford residents.

- Engaging in criminal activity on the premises;
- Threatening the health or safety of other residents;
- Damaging or posing an immediate and significant risk of damage to property;
- · Violating any applicable building code, health ordinance, or similar regulation relating to health and safety; or
- Violating any other contractual obligation (other than late fees, penalties, or interest)




ROCKFORD HOUSING AUTHORITY AND RENEWAL TURNING POINT



PRAIRIE STREET LEGAL AND THE COMMUNITY



CARANDUS BROWN-BOOK OF POETRY VOICES IN THE WIND

Rockford Housing Authority is proud to announce Carandus Brown; ROSS Program Case Manager has published a book of poetry titled "Voices in The Wind." The poems are about different aspects of his life and how God has inspired him throughout his life. Writing started for Carandus in 1992 and was a helpful tool for him to learn how to read. With the help of an instructor who realized his potential, he told him to take his pent-up anger and emotions and translate it into writing and help him with his overall reading and writing skills. Whenever Carandus had certain feelings, he would write them down and reflect on how they relate to his day to day situations. After journaling for a couple of months, Carnadus and his instructor decided to put these words and emotions into poetry. "From there, I just took off with it. I started writing throughout the day and night," Stated Carandus. Writing for Carandus not only started as a way to help with reading and writing skills but also because of his relationship with God;

"Writing poetry also started from my relationship with God, and helped me build a strong relationship." The ability to write poetry is a way to express emotions and different aspects of life. Carandus stated that his poems transcend into his work and home life. His work life at RHA - is because he is passionate about helping people and helping them make changes in his life. His home life because he is a father of 6 children, which can be tedious at times. He states, "Poetry helps me be able to take a step back and write. I can put everything chaotic and just focus and breath." "Overall, it helps me be able to relate to people and be able to continue smiling. I am happy every day and helps me stay happy." Carandus said. Everyone has a method of clearing their mind and relaxing, writing and poetry is Carandus's. Throughout his book, you can see a sequential aspect to it. The first poem he wrote is



HELP FOR ILLINOIS FAMILIES

The Pritzker Administration, in partnership with the Illinois Department of Commerce and Economic Opportunity, has launched a new plan to help Illinois families access energy assistance and other essential services during COVID-19. These are programs for eligible Illinois families seeking emergency assistance to cover utility bills, rent, food, and other necessities.



This initiative is available for all qualifying households with low income. The eligible families may qualify for hundreds of dollars of support for the following services: Water/Sewer Payment, Food, Financial Management, Energy Utility Bill Assistance, Rental Assistance, Temporary Shelter, Employment Training/Placement.

The documents needed to prove eligibility are Social Security card, proof of the past 30-day income through a pay stub, check, or copy of the check showing fixed income amount, or other proof of documentation for any income source, and a utility bill if you are seeking assistance for utility assistance, the last thing is a lease is seeking for rental assistance.

Help for Illinois Families is administered by DCEO's Office of Community Assistance. DCEO manages three federal programs; Low-Income Home Energy Assistance Program (LIHEAP), Community Services Block Grant Program (CSBG), and the Illinois Home Weatherization Assistance Program (IHWAP). Landlords who participate in the Housing Choice Voucher (Section 8) program who accept IHDA ERA funding may jeopardize their Housing Assistance Payment (HAP) contract and may be required to return any funds received.

ILLINOIS CORONAVIRUS HELPLINE:



Illinois officials say a state helpline has been set up to provide emotional support and quick answers to questions about the coronavirus pandemic.

Illinoisans can test "TALK" to 55-2020 (or "HABLAR" for Spanish), and within 24 hours they will receive a call from a counselor. Residents can also text keywords such as "UNEMPLOYMENT," "FOOD" or "SHELTER," to the same number to receive additional information about those topics.



DID YOU KNOW

There are somewhere around 3300 Public Housing Authorities in the United States but the majority of them are extremely small with unit counts in the neighborhood of 50-1000... RHA has more than 1300 Low Income Public Housing units. Public Housing was established to provide decent and safe rental housing for eligible low-income families, the elderly, and persons with disabilities. Public Housing comes in all sizes and types, from scattered single-family houses to high rise apartments for elderly families. There are approximately 1.2 million households living in public housing units.
