# Free COVID-19 Tests to Be Mailed By US Government: How To Order In IL

The Biden administration announced Wednesday Sept. 20, it will provide hundreds of millions of dollars to help produce new, at-home COVID-19 tests, and restart a website that will allow residents in Illinois to once again order up to four free tests per household.

The tests are coming back amid a nearly 8-percent rise in hospitalizations during the week of Sept. 9, the most recent data available on the Center for Disease Control and Prevention's website. Deaths were up 2.3 percent as well across the country. In Illinois, hospitalizations were up 7.3 percent (643 total), and deaths remained unchanged from the previous week, according to CDC data.

### How to order

Orders can be placed at <u>COVIDTests.gov</u> starting Monday, September 25, 2023 the Department of Health and Human Services said. The tests will be delivered for free by the U.S. Postal Service.

They stand as places of reverence, gathering, and celebration, embodying the deep connections Indigenous people maintain with their ancestral lands. Through the diligent work of organizations like the IDNR, these sites are

- RHA will offer a \$500 Payment to existing landords who lease a unit to a housing choice voucher participant.
- The incentive does not apply to those who transfer new units owned by the same landlord.

### **Limited Damage Claims:**

• RHA will offer a one-time payment, not to exceed one month's contract rent or a \$1,000 to the landlord where a housing choice voucher participant's tenancy ends and there is a tenant caused damage to the unit that exceeds the security deposit collected by the owner.

A few of our programs include:




• The Family Self-Sufficiency Program: FSS is a voluntary program established by HUD to promote economic self-sufficiency among RHA participating families.

# **Bully Prevention Month**

Bringing awareness for children that have been or are being bullied, is why Bully Prevention Month was established. The month of October, PACER's National Bullying Prevention Center hosts events and activities to raise awareness on the local and national level. According to the National Prevention Center, 'one in every five children, either yours or your child's friends, report being bullied in school'. 49.8% of tweens (nine to twelve years old) said they experienced bullying at school and 14.5% of tweens shared they experienced bullying online. (Patchin & Hinduja, 2020)

Prevention Month is a grassroots effort to stop bullying and it starts with you. During this month, you can learn how to recognize that your child may be getting bullied.

PACER OR THE PACER OF THE PACER

Bringing awareness to bullying is the highlight of the month. The PACER's National Bullying Prevention Center designates the third Wednesday of October, this year lands on October 19th as Unity Day! You can demonstrate and also express your support for your child, by wearing orange on Unity Day. By wearing orange, you show your child that you are supportive of acceptance, kindness, love, and inclusion.

As an adult who parents, you play a vital role in your child's life. While 'bullying is not a nice thing' and has lifelong consequences, it can also lead children to bouts of depression, truancy, and suicide. As a parent, you must be diligent and vigilant on all levels of your children's social behavior.

1. Help, assist, teach and empower your children about bullying and its damage and impact on another person. You want to teach them that the behavior is unacceptable. At the same time, you also want to ensure that your children get help and support immediately if your child is the recipient of bullying behavior, whether in person or in or on cyber/social platforms.

2. As a parent, you already know the vast importance of keeping the lines of communication open. For example, a continuous daily and weekly dialogue engages your children and demonstrates your feelings and caring about what they think and how they feel. Starting, it may feel somewhat awkward and, in their face, to ask outright, "What did you do in school today?". You will be surprised at the results!





# NATIONAL TAKE A BULLYING STAND PREVENTION MONTH

3. Encourage kids to do what they love. Giving your child something that they love to do will help boost their confidence and empower them to make the right future choices in their life. Finding opportunities that engage your children will also encourage and assist them in making new friends. As a potential outcome, it may keep your child protected from bullying behavior.

4. Last but not least, be a model of how to treat others. We show our children that these rules are not just for them but for us as well. As a parent, your behavior is what your children will emulate in their daily and future adult life. You are demonstrating and modeling the proper behavior by teaching by example to treat others with love, caring, and kindness. As parents, we too can fail even with our best efforts; however, this does not go unnoticed. It also teaches your children how to apologize and repair after a mistake or moment of disconnect.

### **KEY TAKEAWAY**

By utilizing the four action items described above, you have the potential to create an atmosphere of kindness. Well-liked children display more positive, less bullying behaviors when they become teenagers and grow into adults. As a result, happier kids are more likely to show higher academic achievement.

Laura Snyder's Remarkable Five-Year Journey at Rockford Housing Authority

In the world of affordable housing, where change is often slow and challenges are abundant, Laura Snyder stands as a beacon of transformation and progress. As the CEO of the Rockford Housing Authority for the past five years, her tenure has been marked by a string of notable accomplishments that have significantly improved the lives of residents and the community as a whole.



# **Financial Achievements**

One of the cornerstones of Laura Snyder's leadership has been her remarkable ability to secure funding for critical programs and initiatives. Under her guidance, the Rockford Housing Authority secured a Jobs Plus award of a staggering \$2.3 million, creating two internal employment positions and six resident positions, thus stimulating economic growth within the community.

Furthermore, Laura successfully obtained annual awards of \$219,000 for three years and \$144,000 for two years for the Family Self-Sufficiency (FSS) program, providing vital resources to empower families towards self-sufficiency.

The commitment to residents' well-being is evident in the \$731,000 award for the Resident Opportunity and Self-Sufficiency (ROSS) program, emphasizing self-reliance and development. Laura's dedication to safety is also evident in the \$240,000 award for Radon remediation, ensuring the health of residents.

However, perhaps the most outstanding financial achievement during her tenure was securing a massive \$5 million award for Lead-Based Paint remediation, addressing a significant health hazard. Additionally, a \$5 million award for addressing Housing related Hazards underscores her unwavering commitment to improving living conditions for the community.

Laura Snyder's leadership also facilitated homeownership through the Low-Income Public Housing (LIPH) program, enabling residents to achieve the dream of owning their homes. Not content with these accomplishments, she created a Section III compliance and education program that not only ensured compliance but also generated revenue, garnering accolades as an award-winning program.

Securing utility company funding totaling \$1,036,782.00 for upgrades in Blackhawk and Scattered Sites demonstrates her ability to bring resources to

where they are needed most. Perhaps one of the most critical financial achievements was achieving full compliance with HUD reporting requirements, ensuring transparency and accountability.

Laura's financial acumen also shone through in building reserves to more than double the previous balance, providing a safety net for future endeavors. Her commitment to financial integrity is further underscored by maintaining clean financial audits for the past five years, a testament to her dedication to sound fiscal management.

Multiple \$5,000 grants from Associated Bank for Resident Programming, a \$15,000 grant from BMO for Resident Home Ownership, and a \$5,000 grant from the Community Foundation are just a few of the ways Laura Snyder has tirelessly sought financial support to uplift the community.



# Redevelopment

Laura Snyder's visionary leadership extended to redevelopment efforts as well. She successfully recaptured Scattered Sites, ensuring greater control over housing resources. Securing a section 18 award for Brewington Oaks and presenting the board with five redevelopment strategies resulted in the creation of two employment positions and breathed new life into the community.

The section 18 award for Fairgrounds paved the way for its redevelopment, further expanding affordable housing options for the residents.

Her commitment to increasing affordable housing units in the community was evident in the development plan for Bridge Rockford, a testament to her unwavering dedication to community betterment.

# **Operations**

Effective operations are the backbone of any organization, and under Laura Snyder's leadership, the Rockford Housing Authority has excelled. She created and implemented a robust COVID-19 response, including a dedicated website page and an employee salary protection plan, safeguarding the well-being of both staff and residents.

Her ability to manage the agency effectively during a government shutdown demonstrated her adaptability and resilience in the face of challenges.

Attaining Moving to Work (MTW) status was a significant milestone, leading to the creation of three internal employment positions and offering residents increased opportunities for self-improvement. Relocation can be a challenging endeavor, but Laura achieved successful relocations for both Brewington Oaks and Fairgrounds residents, ensuring their comfort and safety throughout the process.



Laura prioritized ongoing training for all staff levels, emphasizing the importance of continuous improvement. Advanced training for key staff members enhanced the overall competence of the organization.

The introduction of an automated payroll platform promoted efficiency and a self-service portal for employees, streamlining administrative processes.

# **Human Services**

Leading the agency to become certified instructors for Bridges out of Poverty and certified LIHEAP case workers to assist the City of Rockford and residents added valuable revenue sources while addressing critical community needs.

Establishing an Empowerment Center at Blackhawk and COCC created hubs of support and empowerment within the community.

Her dedication to fostering homeownership through the Low-Income Public Housing (LIPH) program provided families with a pathway to secure housing stability. Two award-winning programs, the Youth & Police officer program and Resident Relations, showcased her innovative approach to community-building and positive engagement.

The creation of the Women of Influence annual event celebrated the achievements and contributions of women in the community, inspiring future leaders.

Laura's commitment to digital empowerment was evident in the continuation of the ConnectHome program, securing additional grants to provide devices to participants.

Additionally, the launch of the Life Force Development Institute, including the creation of the "Launch My Future" website, opened up new opportunities for personal and professional growth.



RHA is excited to announce the Ready to Rent, Certified Renters course that began on September 11th will be completing the program soon!

Ready to Rent is a 4 week tenant readiness course designed to help renters learn their rights and responsibilities in addition to helping those with rental barriers access housing. This innovative educational program is created with the assistance of landlords, housing providers, and curriculum specialists to give participants direction on the entire rental process and focuses on success for both landlords and tenants. In the class participants work closely with housing specialists and peers to:

- · Overcome Barriers to Rental Housing
- · Tenant responsibilities
- · Repair credit
- · Create a workable budget
- · Prioritize housing needs
- · Develop a housing search plan
- · Understand the application and rental process
- · Maintain appropriate housekeeping
- · Communicate effectively with landlords
